#### **Má tá cás Covid dearfach i rang do pháiste:**

1. Ba chóir don tuismitheoir an scoil a chur ar an eolas má tá cás dearfach i rang do pháiste
2. Rachaidh an scoil i dteaghmáil leis an FSS chun comhairle a lorg
3. Déanann an FSS gach cás a mheas go h-aonarach. Déantar cinneadh bunaithe ar an eolas a bhailítear ón scoil
4. Molfaidh an FSS ceann amháin daoibh seo a leanas:

(i) go bhfanfaidh faighneog amháin amach ón scoil ó lá 1 go lá a 10 (is é an FSS a dhéanann an cinneadh faoi cén lá é lá 1 & lá 10 srl)

**nó**

(ii) go bhfanfaidh dhá fhaighneog amach ón scoil ó lá 1 go lá a 10

**nó**

(iii) go bhfanfaidh an rang iomlán amach ón scoil ó lá 1 go lá a 10

5. Rachaidh an scoil I dteaghmáil le tuismitheoir aon duine (dalta) atá aitheanta mar dhlúth-theaghmálaí (tríd e-phost).
6. Seolfar ephost le treoir ón FSS amach chuig na tuismitheoirí cuí
7. Beidh ar aon dalta atá aitheanta mar dhlúth-theaghmálaí fanacht amach ón scoil go dtí dáta áirithe
8. Deimhnóidh an FSS leis an scoil céard iad lá 1 agus lá 10
9. Beidh ar aon dalta atá aitheanta mar dlúth-theaghmálaí dul agus scrúdú Covid a fháil láithreach

- Deimhnóidh an FSS cén dáta é **lá 1**
- Deimhnóidh an FSS cén dáta é **lá 10**
- Beidh ar an dlúth-theagmhálaí dul faoi scrúdú Covid chomh luath is gur féidir nuair a chuirtear ar an eolas gur dlúth-theagmhálaí iad.
- Beidh ar an dlúth-theagmhálaí dul faoin dara scrúdú Covid ar lá 10 arís.
- Beidh an páiste in ann filleadh ar scoil má thagann an toradh don dara scrúdú seo ar ais diúltach agus muna bhfuil aon siomptóim aige/aici

## Siomptóim Covid-19:

Má léiríonn do pháiste aon de na siomptóim a bhaineann le Covid-19, moltar gan iad a sheoladh isteach ar scoil. Moltar teagmháil a dhéanamh le do GP agus srian a chur ar ghluaiseachtaí do pháiste.

## Confirmed Positive Covid-19 Cases

### Guidance from GSNP

*Dear parent/guardian,*

*Please read the following information as a guide for you in the event of a confirmed positive Covid case in your child's class:*

***If there is a confirmed Positive Covid case in your child's class:***

1. *A parent should notify and inform the school if their child is a confirmed positive Covid case*
2. *The school will contact the HSE and seek advice.*
3. *The HSE will gather information from the school and carry out an assessment (each case is assessed individually)*
4. *The HSE (Public Health) will recommend one of the following:*
  - *That members of the same Pod as the confirmed positive case will be identified as close contacts and will be excluded from the school for a specified period*

***Or***

- *That members of up to 2 Pods will be identified as close contacts of more than one confirmed positive case and will be excluded from the school for a specified period*

***Or***

- *The entire class and members of staff will be excluded from the school and will be required to restrict their movements for a specified period*
5. *The school will contact the parent of a child who has been identified as a close contact and confirm the same (contact will be made via e-mail)*
  6. *An e-mail will be sent to the parent of a close contact with guidance on how to proceed (HSE guidance)*
  7. *Any child identified as a close contact will have to remain absent from school for a definitive period (This will be determined by the HSE)*

8. The HSE will confirm dates identifying Day 1 and Day 10

9. Any child identified as a close contact will be recommended to undergo a Covid test as soon as possible

10. Any child identified as a close contact will be required to restrict their movements

11. If your child tests positive, the HSE will advise how to proceed

12. If your child is not identified as a close contact, your child does not need to undergo a test for Covid-19, they can continue to attend school and no further actions are required at that time. The school will not make contact with parents of children in a class with a confirmed positive case if they are not identified by the HSE as a close contact

## Day 1 and Day 10:

- The HSE will confirm the dates for Day 1 and Day 10
- Any identified close contacts will be recommended to undergo a test for Covid-19 as soon as possible
- The close contact will have to undergo a further test for Covid-19 on Day 10
- If the result is negative, the child may return to school once he/she has no symptoms

## RE: Symptoms:

If your child develops any symptoms suggestive of COVID-19, please do not send your child to school, contact your GP and begin restricting your child's movements, as per public health advice. Restricted movements means avoiding contact with other people and social situations as much as possible.
