Dear Parent/Guardian,

There is currently a problem with parking outside the school premises. It is in fact a safety issue. It is particularly concerning at the following times:

- (1) In the morning before school begins. The teachers and other members of the school team are experiencing difficulties and delays trying to access the school.
- (2) From 1:30pm 200p.m. There is an issue here when the parents are collecting the children (junior/senior infants) from the school. It is not permitted to park outside the school on any side of the road after the left hand turn as you approach the end of the road

(3) From 2:25pm – 3:00pm. The marked parking spaces situated directly outside the school gates are for the buses only. No other vehicle is permitted to park here.

There are cones laid out at certain points on the road. The cones at the bottom (temporary cul-de-sac) are laid out to provide a temporary walkway for the children to cross safely to the other side of the road. This is to ensure the safety and protection of the children. I recognize that it can be an inconvenience and that there is a significant volume of traffic all at once.
